

**Contract to open an account, version 01,
to purchase data from the *icriq.com* site,
Centre de recherche industrielle du Québec's site**

TERMS AND CONDITIONS

1. Opening an account

1.1 Procedure

Opening an account will allow you to purchase data from the *icriq.com* site without having to use a credit card. To open an account, you must read and accept the terms and conditions of the present contract, fill out and sign the membership form, and send it to us along with a check in the amount of your choice (minimum \$200 CND). This amount will then be deposited by the CRIQ in a deposit account for online purchases, thereafter "the account".

Once your membership form and your check have been received, the CRIQ will provide you with an access code and password that will allow you to purchase data online directly from your account.

1.2 Account management

To make new deposits, you must send us your membership form along with a check.

The CRIQ will notify you by e-mail when the balance of your account will be below \$100 CND.

1.3 Account statement

The access code and password that you are provided with when you join this online service allow you to view your account statement at all times. You can also modify your password as you wish.

1.4 Termination

You can terminate the present contract at any time by providing a written notice at least 15 workdays prior to termination. Upon receipt of your notice, the CRIQ will deactivate your access code. A \$75 CND, plus tax, administrative fee will be charged to your account or billed if your balance is insufficient. The balance of your account will be returned to you, if applicable, within 10 workdays following deactivation of your access code.

The CRIQ can rightfully, without prejudice, and without further delay or notice terminate one's rights, under the present contract, to use this service if terms and conditions are not followed and respected. Your access code is then automatically deactivated.

1.5 Applicable law

The present contract is governed and interpreted by the applicable laws of Québec as well as those of Canada that apply. In case of conflict over any item of the present contract, the competent courts of the district of Québec (Québec, Canada) have jurisdiction.

2. Purchasing data from the *icriq.com* site

2.1 Fees and services

A description of the fees and services can be found on the *icriq.com* site. These fees and services can be modified occasionally by the CRIQ without further notice. Such modifications will then be displayed on the *icriq.com* site. It is assumed that you accept these modifications if you continue to use the services offered by the CRIQ after these modifications have been made.

2.2 Purchasing procedure

To purchase data from the *icriq.com* site, you must identify yourself using your access code and password, and accept the terms and conditions of the license agreement displayed on screen.
